2018 Highlights:

Non-state actors & peacebuilding: Religion, business, rights & conflict

Much of the world's focus is on the role of governments in conflict and peacebuilding. In 2018, the role of non-state actors was the focus of Peacemakers Trust research and education initiatives.

Research and writing by Peacemakers Trust director Catherine Morris on truth, lies, reconciliation and the church in North America, resulted in a paper that has been accepted for publication in mid-2019. A draft is available for reading online.

In early 2018, Peacemakers Trust commenced a project on religion, <u>human rights, and conflict.</u> The University of Victoria's Centre for Studies hosted Catherine Morris for a short community sabbatical to begin research on the international right to freedom of religion or belief. One product of this research so far has been a short online Powerpoint education module on relevant international treaties and instruments guaranteeing the right to freedom of religion or belief.

July and August Peacemakers Trust undertook the supervision of a student from France in a research internship which examined the role of businesses in ensuring respect for human rights internationally. This project was conducted jointly with Lawyers' Rights Watch Canada. The research included exploration of impacts of Canadian transnational corporations indigenous peoples.

Online Resources

Peacemakers Trust's bibliographic resource website received more than 183,000 visits in 2018, a monthly average of more than 15,000 visits. Highest usage occurs during fall and spring university terms. Peacemakers Trust updated its resources nonviolent forms of dissent.

Media monitoring in a posttruth environment

During 2018, Peacemakers Trust resources on "evaluating news reports in a "post-truth" environment" received increased online attention, including increased visits to an online

Peacemakers Trust volunteers are participating in initiatives to explore the responsibility of churches to take up Canada's Truth and Reconciliation Commission's "calls to action" to religious denominations and faith groups to engage in reparative actions with indigenous peoples.

Peacemakers Trust plans continue its initiatives on business, human rights and conflict.
